Recapping the Latest Hoisting Machinery Regulations

On November 8, 2013, new Massachusetts Department of Public Safety (Mass DPS) regulations pertaining to hoisting equipment went into effect (520 CMR 6.00). The regulations apply to any hoisting machinery (including fork trucks and lifting devices) that can lift a load higher than 10 feet, or lift loads greater than 500 pounds.

These DPS regulations require all operators of hoisting equipment to possess a valid, state issued hoisting license specific to the class of hoisting machinery operated. The primary change made in this regulatory revision was to include



an exemption, under very specific conditions, for each operator to possess a Massachusetts DPS hoisting license.

What's Your Source Registration Deadline?

The Massachusetts Department of Environmental Protection has released the 2014 Source Registration schedules and deadlines for all facilities. It has spread out the filing schedule for Source Registration submittals over several months in 2014, as shown below.

- April 15 Operating Permit facilities due
- May 15 Non-OP annual filers due (allowing 1 additional month to file beyond the regulatory deadline)
- June 2 Deadline for a portion of the facilities filing every 3 years (see List of All Facilities for facilityspecific deadlines)
- July 15 Deadline for a portion of facilities filing every 3 years (see List of All Facilities for facility-specific deadlines)

Toxics Use Reduction Reports Due July 1st

The Toxics Use Reduction Act (TURA) requires that Massachusetts companies using large quantities of specific toxic chemicals evaluate and plan for pollution prevention opportunities, implement them if practical, and annually measure and report the results.

This year's toxics use reports, which contain information for calendar year 2013, are due (filed online or postmarked), by July 1, 2014.

EPA's Toxic Release Inventory (TRI) Reporting Due July 1st

The reporting year (RY) 2013 versions of TRI-MEweb, the TRI reporting forms and instructions, the TRI chemical list, and the Threshold Screening Tool are now available for facilities to begin reporting for RY 2013. The deadline to submit TRI forms for RY 2013 is midnight on July 1, 2014. As a reminder to all facilities, a rule finalized in 2013 requires all TRI facilities to submit their TRI reporting forms electronically through the TRI-MEweb reporting application.
