# 2019 Conference Center Training: Course Information

## Safety

### OSHA Basics and Beyond<sup>1</sup>

Review a variety of OSHA standards that are relevant to most every organization, including: manufacturing, water and wastewater treatment facilities, Department of Public Works, healthcare, educational facilities. Standards covered will include: Hazard Communication, Personal Protective Equipment, Lockout/Tagout, Confined Space, Walking Working Surfaces, Ladders, Fall Protection, and more.

### DOT Hazardous Waste Shipping<sup>1,3,4</sup>

This course is designed to meet the training requirements for DOT hazardous material shippers. This class is intended for personnel assigned to manage hazardous waste who are designated to sign hazardous waste manifests.

### RCRA Hazardous Waste Management<sup>1,3,4</sup>

This two (2) hour course is designed to meet the annual EPA hazardous waste training requirements for generators of hazardous waste. This class is intended for personnel assigned to manage hazardous waste.

### Underground Storage Tank Operation<sup>1</sup>

This course will provide operators with the training needed to pass the Federal and State mandated UST operator examination. Curriculum will cover the regulatory requirements for monitoring and testing of cathodic protection systems, double wall tank and piping systems, spill buckets, dispenser sumps, vapor recovery systems, overfill prevention systems and spill protection systems. The course will also review recordkeeping requirements and best management practices for maintaining UST equipment.

### Treatment Plant Equipment<sup>1</sup>

This four (4) hour course will provide a general overview of typical wastewater treatment systems that are found in municipal treatment plants as well as in industry. Special consideration will be given to troubleshooting and problem solving associated with treatment systems. Real life examples will be provided.

### Trench Safety & Confined Space<sup>1</sup>

Wastewater Treatment Plant operators are routinely required to excavate and enter trenches, whether to perform planned maintenance or emergency repairs. Further, operators are regularly presented with the dilemma of entering a confined space. This class will educate them on the regulatory requirements and how to do the work safely.

## Technology

Overview of a wide range of environmental compliance programs & strategies for maintaining compliance.

### Wastewater Treatment Plant Operators Exam Prep<sup>1</sup>

This five-week course is designed for examination preparation. It is an ideal opportunity for prospective wastewater treatment plant operators and current wastewater treatment plant operators looking to upgrade their licenses or obtain TCHs.

### Chemistry for Water & Wastewater Treatment Plan Operators<sup>1,2</sup>

This course includes discussion of the periodic table, elements, and ions in water; neutralization; precipitation; water and wastewater treatment chemistries; and disinfection.

### Industrial Wastewater Treatment<sup>1,3,4</sup>

This eight (8) hour course will provide an overview of typical wastewater treatment systems that are found in industry. Special consideration will be given to troubleshooting and problem solving associated with industrial treatment systems. Real life examples will be provided.

### e-Manifest & Hazardous Waste Shipments<sup>1</sup>

This two (2) hour seminar includes a discussion on the upcoming changes to hazardous waste manifests, how to sign up for the program, common reporting scenarios and a live demo on how to submit a hazardous material using e-Manifest.
